### FIRST ORDER OF BUSINESS

# Call to Order/Roll Call

Ms. Cerbone called the meeting to order at 10:10 a.m. Supervisors Baluja, Orozco and Krause were present, in person. Supervisor Ortiz was not present. One seat was vacant.

#### SECOND ORDER OF BUSINESS

#### **Public Comments**

There being no public comments, the next item followed.

Discussion: Miami-Dade County Department of Regulatory and Economic Resources Notice Regarding Response to Comments/Sampling Plan Dated September 30 2019 and Prepared by SCS Engineers (SCS) for the Landmark at Doral Community Facility (SW-1656/File-24963) Located at, Near, or in the Vicinity of Northwest 102<sup>nd</sup> Avenue and Northwest 66<sup>th</sup> Street folio no. 35-3017-040-3050), Miami, Miami-Dade County, Florida

This item, previously the Seventh Order of Business, was presented out of order.

Mr. Alvarez distributed the Fourth Supplemental Engineer's Report and discussed the following:

December 12, 2019

This was an instance of environmental pollution involving the lake at the northeast corner of the District, within the east parcel.

The purpose of the lake is mainly for stormwater management and monitoring; muck was stripped from the site and placed at the bottom of the lake.

The Department of Environmental Resources Management (DERM) permitted the lake and placed conditions on the permit to monitor the muck for metals and/or ammonia; the readings must be kept at certain levels below their criteria.

There is an excess of iron in the lake and DERM issued a notice to the CDD to investigate how far the iron plume expands beyond the lake.

The project includes well installations, water and soil sampling and analysis reports. The Fourth Supplemental Engineer's Report details the project and discloses that, since the lake is within the east parcel, bond funds dedicated to that parcel could be used to conduct the investigation, which is estimated not to exceed \$70,000. The Report was previously circulated to District Counsel, Bond Counsel and the District Manager, who are considering utilizing funds from the Series 2016 Construction Account to fund the cost.

Discussion ensued regarding the project, the financing and the east parcel.

THIRD ORDER OF BUSINESS

Consideration of Fourth Supplemental Engineer's Report (Infrastructure Improvements)

Ms. Cerbone presented the Fourth Supplemental Engineer's Report.

On MOTION by Ms. Baluja and seconded by Ms. Orozco, with all in favor, the Fourth Supplemental Engineer's Report, as presented, was approved.

On MOTION by Ms. Baluja and seconded by Ms. Orozco, with all in favor, the SCS Engineers Consulting Services Agreement for Reinstallation of Onsite Monitoring Wells, was ratified.

Ms. Cerbone presented the Consulting Services Agreement for Well Installation and Sampling, in the amount of \$23,705.

Ratification of FMSbonds, Inc., G-17 Disclosure

This item, previously the Fourth Order of Business, was presented out of order.

Ms. Cerbone presented the FMSbonds, Inc., G-17 Disclosure. The document was executed and the 2006 bonds were refinanced.

On MOTION by Ms. Baluja and seconded by Ms. Orozco, with all in favor, the FMSbonds, Inc., G-17 Disclosure, was ratified.
